Ms. Black approved the Treasurer's Reports and payment of the bills as presented.

- 5. Resignation of Donald Lundmark and Mike Benton and appointment of directors to fill the unexpired terms.
- 6. Election of officers.

Mr. Marez explained that the resignations of Mr. Donald Lundmark and Mr. Mike Benton have left two vacancies on the Board which can be filled at the next Annual Meeting. Ms. Kathy Lowman has volunteered to serve on the NWSC board. A new Vice-President will need to be elected as well. He added that once all Board members are elected or appointed, selection of a new Vice-President can take place.

7. Fiscal Year 2021 Budget Amendments.

Ms. Wagner reviewed the proposed Fiscal Year 2021 Amended Budget which reflected a decrease in Revenues of \$32,116 and a \$66,898 increase in Total Expenditures for a Net Loss of \$245,774. She pointed out that the depreciation expense of \$333,000 is not a cash flow item. Ms. Black accepted the amendments as presented.

8. Proposed Fiscal Year 2022 Budget and retail water rates

Ms. Wagner presented the proposed Fiscal Year 2022 Budgets based on the current rates as well as three additional scenarios based on various monthly minimums and tier rates. She explained that the City of Corpus Christi water rate will decrease in January 2022 by 50 cents per thousand gallons and recommended maintaining the current rates. She added that keeping the same rate could help accumulate funds for system repairs. Ms. Black agreed with leaving the rates the same.

9. **Resolution 21-04.** Resolution adopting the recommended Fiscal Year 2022 Budget.

Ms. Black gave verbal approval in support of Resolution 21-04 keeping the same water rates for Fiscal Year 2022.

10. John Womack & Co., P.C. Letter of Engagement for Auditor Services.

Mr. Marez presented the John Womack & Co., P.C. Letter of Engagement for auditor services for the fiscal year ending December 31, 2021 with a cost of \$5,575. Ms. Black gave approval to accept the engagement letter for FY 2021 audit services with John Womack & Co., P.C. in the amount of \$5,575.

11. Annual Meeting Schedule and Election Procedures.

Mr. Marez stated that per State requirements, the Board must review Election Procedures for the Annual Membership meeting. The positions currently held by Ms. Smith and Ms. Zimmerman are up for election in April of 2022. In addition, the two vacancies remaining on the board after Mr. Benton's and Mr. Lundmark's resignations need to be filled. He presented TRWA's Election Procedures 2021 Changes and reviewed the following recommended changes:

- 1. The COVID-19 letter has been updated with TRWA's current advice on holding meetings during the ongoing pandemic.
- 2. Language was stricken from page 4 of the TRWA Elections Procedures which previously allowed board candidates' personal information to be kept confidential.

He also presented the timeline and schedule for the 2022 Annual Membership Meeting and asked for approval to proceed with the schedule and to incorporate the recommended changes in the Corporation's Election Procedures. Ms. Black reviewed the proposed schedule and the notice to members on submitting an application for the NWSC Board of Directors and authorized incorporating the changes into NWSC's procedures, mailing of the presented documents and proceeding with the recommended schedule.

12. Emergency Preparedness Plan.

• Ardurra Proposal for Engineering Services

Mr. Marez stated that the documentation needed to complete the Emergency Preparedness Plan is extremely complex and many water providers have outsourced the task. He added that Ms. Wagner requested a bid from Ardurra for completion of the document. He presented Ardurra's quote in the amount of \$5,620 and recommended entering into the agreement. Ms. Black gave approval to accept Ardurra's proposal in the amount of \$5,620.

13. Purchase of materials to build up NWSC stockpile of materials due to stagnation in PVC production and transportation issues.

Mr. Marez reported that over the last few months, staff has noticed an increased cost and scarcity of materials in the water utility industry including shortages of PVC pipe, fittings, valves and similar materials. The Corporation's supplies remain in adequate amounts, but there is a delay of 1 ½ to 8 months in delivery of materials. He requested authorization to look into purchasing

materials to serve as a stockpile to ensure the availability of materials for repairs and other projects. He added that a Houston manufacturer is available to provide material but at a steep price. Ms. Black gave approval to do so and when an estimate is ready, to proceed with acquiring the materials.

14. Request for service – Vaquero Ventures on FM 666.

Mr. Marez reported that developer Vaquero Ventures is looking into building a convenience store on FM 665 on the east side of the bypass. Vaquero is interested in taking on the majority of the cost for expanding to this area but has asked that NWSC consider sharing the cost of installing the waterline since it could lead to future customers for the corporation. Currently a two-inch line provides service to the area but this line does not have the capacity to service the proposed development. A four-inch line will need to be installed costing approximately \$80,115.16. If the cost is shared, Vaquero's portion would be \$62,489 and NWSC's portion would be \$17,654. Ms. Black agreed for NWSC to share the cost and pay \$17,654.

15. Update on Texas 811 changes.

Mr. Marez reported that because of recent changes, the Texas 811 emergency locate policy now provides up to three hours for locaters to mark lines during emergency situations. He stated that he wanted to make the Board aware of the changes since, in some cases, crews might have to wait up to three hours to begin excavations on repairs. No action was taken by the Board.

- 16. Acceptance of easements for NWSC for Triple-T Farms Grain Facility.

Ms. Black reviewed the easements provided by Triple-T Farms and approved accepting the easements.

17. Adjournment.

With no further business to conduct, Ms. Black adjourned the meeting at 3:21 p.m.

On the August 3, 2021 board meeting discussion and action was taken on the Utility Conveyance Agreement transferring facilities from Nueces County to South Texas Water Supply Corporation and Nueces Water Supply Corporation. This conveyance has been in the works since 2018 when Nueces County and the Nueces County Water Improvement District #5 began an agreement to handover resources based on a county led water development project located in Cyndi Park. This agreement allowed the county to participate in grant funding available to them and allowed them to contract and work on behalf of this project with the eventual goal to transfer assignments of the facilities and resources for all parties involved including STWA, NWSC and NCWID#5. The board's unanimous approval was given based on Nueces County's Grant Department and County Attorney would sort out the assignments of each conveyance. The Nueces County Commissioner's Court approved this action on condition of the conveyance language. After several months of reaching out to Nueces County their finalized version of the Conveyance was given to the STWA this week for final review.

Analysis:

The conveyance language involves several entities that most review and approve before any conveyance is finalized. This conveyance must also be presented to the Nueces Water Supply Corporation since they are a party to this agreement.

Staff Recommendation:

Allow staff and the NWSC board to review the finalized language. Since STWA board approval has already been given at the September 2021 meeting the conveyance will be confirmed valid by staff and legal.

Board Action:

Review the attached conveyance language and allow staff to verify all obligations have been met.

Summary:

After several months of no response the STWA received the final conveyance language from Nueces County. Board approval has been given and minor details need to be verified before this agreement can be determined complete.

You are correct the NWSC is a membership owned non-profit, which contracts with the STWA to provide total "turn-key" services including administrative/office services, field staff services (along with equipment/infrastructure) and delivery of water to the NWSC's customers.

The STWA purchases surface water from the City of Corpus Christi and in turn acts as a water wholesaler to seven retail customers (including the Nueces County Water Control Improvement District #5 -Banquete).

UTILITY CONVEYANCE AGREEMENT BETWEEN NUECES COUNTY AND SOUTH TEXAS WATER AUTHORITY

This Agreement is made and entered into effective________, 2021 by and between the South Texas Water Authority, a Texas Authority organized under Article 1434a of Vernon's Annotated Texas Civil Statutes, (herein referred to as "Authority") and Nucces County, Texas, a political subdivision of the State of Texas, whose address is 901 Leopard, Corpus Christi, Texas 78401 (herein referred to as "County").

WHEREAS, the Authority, was created for the purpose of furnishing water to the land within its service area and is recognized as a political subdivision for certain purposes;

WHEREAS, the County, pursuant to Texas Water Development Board Project No. 62622, has installed and acquired ownership of a water distribution system, "Facilities," as outlined in detail in Exhibit A to transport fresh water to the Cindy Park and The Ranch Colonia;

WHEREAS, the County may periodically sell the County's surplus property to another political subdivision with the County in accordance to Chapter 263 of the Texas Local Government Code;

WHEREAS, the County desires to dispose of the Facilities as surplus property as defined by Section 263.151(2) of the Texas Local Government Code to Authority, and

WHEREAS, the Authority is providing water service within the County and Authority shall provide maintenance and repair of the Facilities in exchange for the applicable conveyance of the Facilities; and

WHEREAS, the County wishes to convey and Authority wishes to take title to such Facilities so that Authority can provide fresh water in the service area.

NOW THEREFORE the parties for and in consideration of the premises and of the mutual obligations, covenants, and benefits herein after set forth, agree as follows:

1. CONVEYANCE OF UTILITY.

County hereby sells, conveys, transfers and delivers to Authority improvements, Facilities, made as part of Texas Water Development Board Project No. 62622, free and clear of all liens, claims, encumbrances, options, charges, assessments, reservations, or restrictions. The Facilities being conveyed are as described in Exhibit A herein attached.

2. ASSIGNMENT

County hereby assigns all of its rights pertaining to Facilities made as part of Texas Water Development Board Project No. 62622 under Construction Contracts to Authority and agrees to make provisions for the transfer of the performance and payment bonds, and guarantees and warranties executed by the contractors and all other rights of County pursuant to the provisions of the Construction Contracts.

3. REPRESENTATIONS BY COUNTY

Except for the warranties expressly set forth herein, and the express covenants of County set forth herein, there are no warranties given by the County to Authority, expressed or implied, and all such warranties are hereby disclaimed by County and released by Authority. County represents to Authority that:

- (a) The Facilities hereby conveyed to Authority is free and clear of all liens, claims, encumbrances, options, charges, assessments, reservations, and restrictions.
- (b) County warrants and represents that, at the same time of this conveyance, the Facilities meet all requirements of the County and all other state and governmental requirements.
- (c) County represents that the Facilities have been constructed entirely within the dedicated county and public right-of-way, except for easements previously acquired by the County.
- (d) County is in possession of Facilities and no objection to the location or use of the improvements or adverse claims of title to the lands, easements, rights-of-way, licenses, permits, or leases on which the improvements are situated are presently being asserted by any person or persons.
- (e) There are no actions, suits, or proceedings pending or, to the knowledge of County, threatened or affecting the Facilities to be conveyed hereunder and there are no pending condemnation proceedings of which County is aware connected with the improvements being conveyed hereunder.
- (f) This Agreement, the transactions contemplated herein, and the execution and delivery of this Agreement have been duly authorized by County.
- (g) This Agreement, and the warranties, representations, and covenants contained herein, and the consummation of the transactions contemplated herein will not violate or constitute a breach of any contract or other agreement to which County is a party.

4. EXPENSES

Except as specifically set forth herein, each party shall pay its own expenses incident to carrying this Agreement into effect and consummating all transactions contemplated hereby.

5. FURTHER ASSURANCES

In connection with this Agreement as well as the transactions contemplated by this Agreement, each signatory party hereto agrees to execute and deliver additional documents and instruments and to perform such additional acts as may be necessary or appropriate to effectuate, carry out and perform all the terms and provisions and conditions of this Agreement and all such transactions.

6. REPRESENTATIONS SURVIVE CONVEYANCE

The Agreements and representations made in this Agreement by the Parties to this Agreement shall survive the conveyance of the Facilities.

7. MISCELLANEOUS

This agreement shall be governed by, and construed in accordance with the laws of the State of Texas and can be amended or terminated only by an agreement in writing by the parties hereto. This Agreement embodies the agreement in writing signed by the parties hereto. This Agreement embodies the entire understanding between the parties and there are no prior effective representations, warranties, or agreements between the parties.

8. RESPONSIBILITIES OF THE AUTHORITY

Authority shall comply with the TCEQ and EPA water quality standards and shall be responsible for daily operations including but not limited to pumps, motors, tanks, force main, leaks, customer concerns, etc. Further, Authority shall be responsible for all maintenance including but not limited to replacement of equipment.

9. INDEMNITY

AUTHORITY, AS PERMITTED BY LAW, SHALL SAVE HARMLESS THE COUNTY AND ITS OFFICERS AND EMPLOYEES FROM ALL CLAIMS FOR DAMAGES BY PERSONS OR ENTITEIS NOT A PARTY TO THIS AGREEMENT, INCLUDING DAMAGES, ATTORNEY'S FEES AND COSTS OF DEFENSE, INSOFAR SUCH CLAIMS ARE BASED ON ANY ACT OR OMMISSION BY AUTHORITY AT ANY TIME RELATING TO THIS AGREEMENT.

Re: Discussion and Action on Proposed NWSC Website Changes

Background:

The NWSC along with the STWA and NWSC have used the same type of format and website designs. This has been a practical use since it allows staff to use only one formatting type instead of several reiterations. During the January 25th board meeting of the STWA their board approved and accepted the use of a company that specializes in Rural Water Company websites.

Analysis:

Using the same website design allows for the NWSC to maintain their own individual website and be able to modify messages, reminders or notices to the public in real time. Our staff will be able to make these adjustments from any location at any time of the day or night and will no longer require staff to come into the office to change these messages. This proposed site allows for all costumers to sign up for email and/or text message notifications of any water boils, office closures, bad weather, etc. The proposed cost is estimated at \$702.75 although the final price could slightly fluctuate.

Staff Recommendation:

Approve a motion to allow Rural Water Impact provide the website design services for the NWSC and match the STWA design as well. Should all three corporations use this company a slight discount will be provided on the year one cost as listed earlier.

Board Action:

Approve a motion to allow Rural Water Impact provide the website design services.

Summarization:

Staff believes this website updates replaces a growing outdates website design. In addition, the NWSC will add a level of communicating directly with customers in real-time to provide any emergency or important system information.

President Black & Board,

I want to update you on my plans for a proposed NWSC website revamp that I will bring at the next board meeting. I have researched several companies and been in communications with a Texas-based website design group, Rural Water Impact, that specializes only with water providers and comes recommended by the National Rural Water Association (NRWA).

Rural Water Impact can provide us a virtual demonstration so you can view their features in real time and ultimately decide if this is something you would support. The websites RWI creates are easy to update, secure, and allows staff to set-up alerts via text messages and emails to our customers for general or emergency updates. We do not have a notification feature with our current website and I believe that Emergency alerts and communications are crucial for water delivery. Attached you will find the pricing for the initial website setup and one year of usage which is roughly \$700 total. Beginning in 2023 our annual renewals are estimated to drop to around a \$450 price tag providing a savings compared to the year-one investment.

Below I have included websites from area water systems which use RWI and they show just how easy it is to navigate within their sites to make payments, retrieve documents and locate useful information. My overall belief with this proposal, and I hope you agree, is that website proficiency is necessary for the NWSC to operate in a user-friendly manner and will help facilitate support for new and existing customers.

Re: Purchasing Stockpile of Materials for Field Operations

Background:

Throughout the COVID19 Pandemic various supplies of materials have been in limited stock including foods and paper products to name a few. Matching that trend, we have observed over the last several months a scarcity of materials in the water utility industry with shortages of PVC pipes, fittings, valves, etc. This is based on the reduced production of petroleum-based products which translates to reduced manufacturing and ultimately rising cost for materials we use to repair water lines or new/existing connections.

While our supplies remain in adequate amounts staff has noticed longer wait times for ordering materials that that in some cases are estimated to take a one and a half (1 ½) to eight (8) months delay in receiving those materials.

Analysis:

All current projects show a continued slow-down of material output for the foreseeable future. This trend also corelates with an increase of materials cost. Immediate action is recommended to gain a substantial amount of supplies to address the corporation's needs.

Staff Recommendation:

Staff recommends purchasing materials to serve as a stockpile to counter the current trends of delays in transporting supplies, decreasing amounts of materials and increasing cost.

Board Action:

Provide staff guidance to purchase materials to ensure the NWSC has an adequate stockpile to respond to daily needs, emergencies and small projects.

Summary:

Due to various factors out of our control, the NWSC faces a possible shortage of materials to fix daily repairs or emergencies. In addition, without an adequate supply of PVC pipe, fittings and values places our crews in a bind to provide immediate relief for the member's emergency or everyday needs. Selecting an amount for stockpile will better ensure that the NWSC has enough resources on hand to fix most, if not all, problems that arise.

Background:

During the December 6, 2021 meeting the board approved entering into a professional services contract with Ardurra/LNV to complete the state mandated EPP also known as Senate Bill 3 (SB3). SB3 was created in response to Winter Storm Uri which took most Texas utilities off-line and presented lift threatening situations for the customers of electric, water and wastewater providers. The principal response to SB3 was to require that all Texas utilities file with their Electric providers for "Critical Load Status" allowing each, priority to receive electricity first for any future infrastructure disasters. The current documentation needed to complete these forms are extremely complex with most water providers seeking to outsource this time-consuming task. The NWSC through our Finance Manager sought an outside bid from Ardurra to complete the 40 plus page (Emergency Preparedness Plan) EPP document to submit to TCEQ no later than March 1, 2022.

Analysis:

The EPP is a time-consuming form that many utility providers are outsourcing since staffing levels cannot devote enough time for this sole responsibility. Using an outside firm will free up time and resources to allow the NWSC staff to focus on their regular essential jobs. This bid amount is on par with other companies offering similar bid estimates.

Staff Recommendation:

Receive Adurra's finalized EPP report submitted to the Texas Commissioner on Environmental Quality.

Board Action:

Review the attached report. Staff will be available to answer your questions during the board meeting.

Summary:

Adurra completed a highly technical form for the TCEQ on behalf of the NWSC by March 1, 2022. This Senate Bill was signed into law in 2021 in response to Winter Storm Uri's impact on utilities throughout the state. This form will help the NWSC reconnect with our electric providers at a faster rate to previous and guarantees prompt water services for the customers.

The EPP is a time-consuming form that many utility providers are outsourcing since staffing levels cannot devote enough time for this sole responsibility. Staff Recommendation:

Staff recommends entering into agreement with Adurra for \$5,620 to complete the form to be submitted to the Texas Commissioner on Environmental Quality.
